



REGIONAL IMPLEMENTATION ON THE RELEASE OF FUNDS FOR PAYMENT OF TERMINAL LEAVE BENEFITS FOR CY 2022

- 1. This Memorandum is issued to cover the procedure on the request and release of funds for the payment of terminal leave benefits of compulsory and optional retirees during CY 2022.
- 2. The FY 2022 regionwide lumpsum appropriation for Administration of Personnel Benefits comprehensively released to this Office amounting to Thirty-Three Million Four Thousand Pesos (P33,004,000.00) shall be utilized for payment of the said benefits.
- 3. Accordingly, all Schools Division Superintendents and Principals of Secondary Schools Implementing Units are advised to submit to this Office, Finance Division, the request for release of allotment to cover the payment of terminal leave benefits of retirees together with the certified copy of the following supporting documents:
 - 3.1 Approval of Retirement from the GSIS Office

3.2 Office/School Clearance

- 3.3 Latest Notice of Salary Adjustment
- 3.4 Certificate of Last Day of Service
- 3.5 Certificate of Leave Credits or approved CSC Form 6
- 3.6 Computation of Terminal Leave Benefits
- 3.7 Certificate of No Available Savings; and
- 3.8 List of Actual Retirees to be Paid
- 4. Based on the evaluated request, this Office shall issue the corresponding Suballotment Release Order (Sub-ARO) to the concerned Schools Division Office (SDO)/Implementing Unit (IU). Upon receipt of the Sub-ARO, the SDO/IU shall either submit to the Department of Budget and Management Regional Office III a request for the release of Notice of Cash Allocation or pay the said benefit chargeable against its available Common Fund balance.
