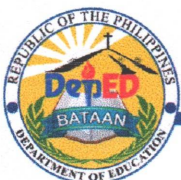
DIVISION MEMORANDUM

FIDELITY BOND FOR ACCOUNTABLE OFFICERS

To: Assistant Schools Division Superintendent
Chiefs of Division, CID and SGOD
Education Program Supervisors
Public Schools District Supervisors
All Public Schools Principals
All Others Concerned

1. The Office reminds all concerned to adhere with the Public Bonding Law¹.
2. Every officer, agent, and employee of the Government of the Philippines or of the companies or corporations of which the majority of the stocks is held by the National Government (NG), regardless of the status of their appointment shall, whenever the nature of the duties performed by such officer, agent or employee permits or requires the possession, custody or control of funds or properties for which he is accountable, be deemed a bondable officer and shall be bonded and his fidelity insured².
3. The following also are required to be bonded²:
 - 3.1 Accountable public officers discharging their duties in a foreign countries;
 - 3.2 Public officers accountable to others who are primarily accountable;
 - 3.3 Public officers designated as authorized signatories and counter signatories in the issuance of checks and approval of disbursement vouchers;
 - 3.4 Heads of departments, bureaus, agencies, and instrumentalities of the Government.
4. Unjustified failure of an accountable public officer to comply with the requirements to apply the Fidelity Bond pursuant to this Circular and the Public Bonding Law shall subject the responsible official/employee to applicable criminal, and/or administrative liability under the Revised Penal Code and PD No. 1445².



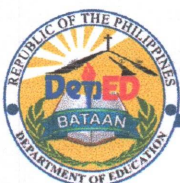
