RECONSTITUTION OF CHILD PROTECTION COMMITTEES IN SCHOOLS AND SUBMISSION OF ITS DATA

- Pursuant to Regional Memorandum No. 034, s. 2022, DepEd Order No. 003, s. 2021, and DepEd Order No. 40, s. 2012, this Office informs the field on the reconstitution of Child Protection Committee in schools and submission of its data.
- This Unit shall be created to plan, implement, coordinate, monitor, and evaluate programs, projects, and activities and includes intervention mechanisms related to child protection at different levels of the Department of Education.
- 3. The Child Protection Committee (CPC) shall be composed of the following:
 - a. Chairperson
 - b. Vice Chairperson
 - c. Representative from the Teacher as designated by the Faculty Club
 - Representative from the Parents as designated by the Parents-Teachers Association (PTA)
 - e. Representative from the Learners as designated by the SPG/SSG
 - f. Representative from the Community as designated by the Punong Barangay, preferably member of the Barangay Council for the Protection of Children (BCPC)
- Further, the CPC of schools shall be submitted on or before February 7, 2022 at 1:00 PM through e-mail: sgodme.bataan@deped.gov.ph or through Google Drive: https://tinyurl.com/BataanChildProtectionCommittee. (See Annex A).
