Consequently, with the advent of technology, school violence also found its way online through cyberbullying.

In the Philippines, the Republic Act No. 10627, otherwise known as the Anti-Bullying Act of 2013, was established to address and prevent all kinds of school bullying and violence. However, it is proving to be an uphill battle. Now more than ever, efforts should be geared towards preventing these kinds of school violence and providing help and support to the victims. Prevention efforts should begin at the top and involve all education stakeholders. Awareness, understanding and joint efforts by the teachers, administrators, community, and the student themselves will help curve and ultimately halt this trend of school-based abuse. School violence is an issue that is of global concern. After all, we must remember that protecting children is saving our future.
