- In reference to Division Memorandum No. 129, s. 2020 entitled Submission of Learner Enrollment Survey Form (LESF) and Remote Enrollment Status Report dated last June 18, 2020, the Schools Division Office of Bataan is issuing these clarifications to comply with the required reports being submitted daily to DepEd Regional Office III.
- 2. Daily report on enrollment, LESF and remote enrollment status should be submitted both by public and private schools.
- 3. Report on enrollment of public schools shall be sent through the Public Schools District Supervisors while private schools shall be submitted to sdobataanplanning.research@gmail.com. Cut off time is 12:00 noon daily.
- 4. LESF Report per grade level both in public and private schools, which shall now include Part C (Parent/ Guardian Information) and Part D (Household Capacity and Access to Distance Learning), and Remote Enrollment Status report shall be submitted through the links below. Provide the data as of June 24, 2020 and update daily until July 7, 2020. Cut off time is 12:00 noon daily.
