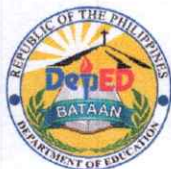

**STRICT COMPLIANCE WITH DEPED MEMORANDUM NO. 031, S. 2020**

To: Assistant Schools Division Superintendent  
Chiefs of Division  
Public Schools District Supervisors  
Public and Private Elementary and Secondary School Heads  
Public and Private Elementary and Secondary Teachers  
All Others Concerned

1. This Office hereby asserts its commitment to the strict compliance with DepEd Memorandum No. 031, s. 2020 entitled "Fourth Set of Policy Directives of DepEd Task Force COVID-19" issued on 05 March 2020.
2. Specifically, all concerned personnel are mandated to religiously observe the provisions of the said DepEd Memorandum regarding travel measures and restrictions, to wit:
  - a. travel measures and restrictions are extended for the month of March 2020, and shall continue to remain in effect, subject to the latest updates and advisories on travel restrictions by concerned authorities;
  - b. official and personal travels are temporarily banned in the following:
    - i. People's Republic of China and its Special Administrative Regions (SARs); and
    - ii. North Gyeongsang Province of South Korea, including Daegu City and Cheongdo County
  - c. official travels of all DepEd personnel and learners' previously approved by the Secretary for the month of March 2020 to countries identified to have confirmed cases of persons under investigation or COVID-19 are revoked; and
  - d. should any personnel or learner decide to proceed with their scheduled personal travels for the month of March 2020 to countries identified to have confirmed cases of persons under investigation or COVID-19, they shall be subject to mandatory self-quarantine for 14 days from the date of arrival in the Philippines.

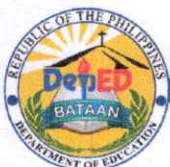
