### **SDO BATAAN AND BPSU JOINT EXTENSION PROGRAM**

To: OIC-Assistant Schools Division Superintendent Chief Education Supervisors Public Schools District Supervisors Public Elementary and Secondary School Heads Assistant Principals All Others Concerned

- 1. The Schools Division of Bataan has entered into a Memorandum of Agreement (MOA) with Bataan Peninsula State University, as it pursues and implements development initiatives. Through the Joint Extension Program, the BPSU shall extend its expertise in sports and culture to the community through SDO Bataan.
- 2. The agreement aims to:
  - a. Develop basic skills in different sports.
  - b. Recognize the innate potential of select pupils enrolled in the different elementary schools in Bataan, particularly in Orani District.
  - c. Encourage the participants to get involved in lifetime sports and fitness-related activities, and
  - d. Improve the performance of Bataan in different sports competitions.
- 3. Attached is the Memorandum of Agreement between Bataan Peninsula State University (First Party) and the Department of Education, Division of Bataan (Second Party).

### MEMORANDUM OF AGREEMENT

### KNOW ALL MEN BY THESE PRESENTS:

This agreement between:

The BATAAN PENINSULA STATE UNIVERSITY (First Party), a chartered state university with principal address at Capitol Compound, City of Balanga, Bataan, represented by its University President, DR. GREGORIO J. RODIS,

-and-

The DEPARTMENT OF EDUCATION, DIVISION OF BATAAN (Second Party) hereinafter referred to as a duly recognized government agency existing and certified to be the implementing agency in education with principal address at the Provincial Capitol Compound, Balanga City, Bataan represented by its Schools Division Superintendent, DR. ROLAND M. FRONDA,

is being entered for the following considerations:

- 1. The First Party is a state university mandated to conduct extension programs and Schools Division Superintendent training services in the community.
- The First Party is cognizant that in order to speed up community development, interagency cooperation is a potent tool that could propel optimum use of resources.
- 3. The First Party recognizes the importance of extending services to the communities through programs in which it has sufficient capabilities.
- 4. The First Party has the capability to extend and support in the field of sports and cultural aspects.
- 5. The Second Party is continuously implementing programs and projects geared towards uplifting the social, economic, cultural and environmental condition of the people.
- 6. The Second Party has established linkages with various government and nongovernment organization to sustain its integrated development framework / plan.
- 7. The Second Party recognizes the urgent need for mutual sharing of resources to achieve development goals.

In accordance with the preceding considerations, the parties have agreed to pursue and implement development initiatives, starting with this JOINT EXTENSION PROGRAM under the following terms and considerations.

#### AMENDMENT PROVISION I.

Amendments to this Agreement shall be done thru a supplementary agreement to be prepared by the party requesting them and shall be entered into upon mutual consent of the parties.

#### **OBJECTIVES:** II.

- Develop basic skills in different sports;
- Recognize the innate potentials of select pupils enrolled in the different 1. 2. elementary

schools in Bataan;

activities; and

4. Improve the performance of Bataan in different sports competitions

#### III. RESPONSIBILITIES:

The First Party shall:

- 1. Provide extensive synchronous and asynchronous training for the coaches and players of the Second Party;
- 2. Provide the necessary skills and other sports assistance for the conduct of related activities;
- 3. Provide other assistance that may be necessary to ensure the success of the program; and
- 4. At all times, maintain the practice of following the guidelines set by the Inter-Agency Task Force on the implementation of Community Quarantine in the Philippines on 'New Normal.'

# The Second Party shall:

- 1. Extend assistance to First Party's Extension Team in the implementation of the program;
- 2. Provide assistance through close collaboration with the participants of the program and the First Party's Extension team;
- 3. Provide the athletes who will participate in the sports program;
- 4. Secure the parental consent and medical clearance of the participating student athletes; and
- 5. At all times maintain the practice of following the guidelines set by the Inter-Agency Task Force on the implementation of Community Quarantine in the Philippines on 'New Normal.'

## IV. Repealing Clause

Both parties agree that this MOA contains the full agreement of the parties and supersedes all previous agreements either written or oral if there are any.

### V. Effectivity:

This agreement shall take effect upon its execution and shall be implemented and effect until the last duration of the agreement.
