Awareness of data privacy regulations was not connected with attitudes about using social media for education. However, there was a correlation between confidence in the government's ability to control social media corporations and comfort with how businesses exploit student and personal data. We talk about our results in connection to social media use, associated data privacy issues, and the demand for data literacy instruction in teacher preparation programs.

Teachers should keep in mind that all student personal information belongs to the student and should be kept private while thinking about privacy. This data consists of

On the other hand, Gallatin, et, al (2022) conducted a study on teachers' role and level of awareness on Safe Internet Use and its Legal Implications in the Conduct of Online Classes during the pandemic. The findings showed that how lessons are conducted online has little impact on how teachers see their roles and that they are better knowledgeable about the crucial safeguards for online safety. Additionally, it demonstrated how drastically varied their levels of understanding of the four aspects of safe internet use are. Additionally, the study was unable to find a connection between instructors' understanding of preserving information privacy and their terms of employment. It demonstrates that teachers, regardless of their years of experience, are aware of their responsibilities under the Data Privacy Act of 2012 as controllers of personal information. The findings of this study will assist schools in educating faculty members about the dependability of computer security programs that can guarantee the protection of personal data and prevent security breaches.

In the Philippine context, data privacy was enacted in 2012 to protect the fundamental human right of privacy, of communication while ensuring the free flow of information to promote innovation and growth. It was also stipulated in this republic act that the state upholds the security and protection of personal information and
