All research proposals must be anchored on the Regional Memorandum 2. No. 185 s. 2020 known as the Harmonized Regional Basic Education Research Agenda. Interested teaching, teaching-related and non-teaching personnel may submit research proposals on the following areas: a) Teaching and Learning; b) Child Protection; c) Human Resource Development; d) Governance; e) Gender and Development; f) Disaster Risk Reduction and Management; and g) Inclusive In addition, research that will be conducted should convey Education. information on raising the quality of education in Region III and be anchored on the Basic Education Learning Continuity Plan as well as on the four pillars of Sulong Edukalidad: (1) K to 12 Curriculum review and update; (2) Improvement of the learning environment; (3) Teachers' upskilling and reskilling; and (4) Engagement of stakeholders for support and collaboration. Correspondingly, the study should also contribute to the effective delivery of the K-12 Curriculum, which is measured based on the four (4) intermediate outcomes and enabling environment outcomes.
