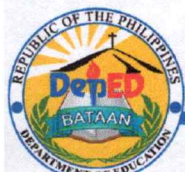
**DIVISION MEMORANDUM**

**CLARIFICATIONS ON SCHOOL ACTIVITIES  
RELATIVE TO END OF SCHOOL YEAR AND EXTENSION OF MECQ**

1. This Office seeks to clarify the guidelines in the conduct of activities relative to the School Year 2020-2021 End of School Year (EOSY) Rites and the extension of the MECQ classification of Bataan Province.
2. The primary responsibility of the schools at this time is to prepare for the virtual EOSY rites scheduled on July 12-16, 2021 in accordance with DepEd Memorandum No. 27, s. 2021. The Checking of Forms as stipulated in Division Memorandum No. 238, s. 2021 shall proceed as scheduled. However, it is stressed that this shall only be done virtually.
3. All other activities that would require the on-site presence of school personnel are held in abeyance. These include the preparations for SBM validation and SMEA presentation as well as submission of LDM portfolio. Separate memoranda regarding the resumption of SBM and SMEA activities shall be issued upon the lifting of the MECQ classification of the province. Meanwhile, the deadline for the submission of documents included in the practicum portfolio is hereby set to August 20, 2021. On the other hand, participation in webinars and other online meetings may continue.
4. School heads, teachers, and non-teaching personnel are repeatedly reminded that the primary concern now is to ensure that no DepEd teacher or non-teaching personnel shall further fall victim to COVID-19. Thus, this Office is extending as much consideration to all its personnel as allowed under DepEd Order 11, s. 2020 and CSC Memorandum Circular No. 18, s. 2021. In return,

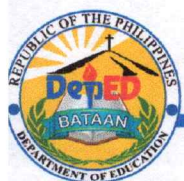
everyone is expected to exercise extreme caution and highest health protocols in all activities.
