CHANGES IN THE DIVISION MEMORANDUM NO. 318, s. 2021 (DISSEMINATION OF DEPED MEMORANDUM OUF-2021-0299)

To: OIC-Assistant Schools Division Superintendent Chief Education Supervisors Public Schools District Supervisors SDO Unit Heads All Public Schools Principals All Others Concerned

- This Office informs all concerned on the changes in the implementation of Division Memorandum No. 318, s. 2021 entitled "Dissemination of DepEd Memorandum OUF-2021-0299 (Advisory on the Release of Additional Maintenance and Other Operating Expenses for FY 2021)".
- The amount of four hundred eighty-four thousand pesos (P 484,000.00) from the six (6) schools initially included in the Elementary allocation will be moved to Secondary allotment in the List of Schools with allocated amount (Enclosure 1).
- 3. Strict adherence to existing health protocols as imposed by the National and Local IATFs for the safety of all shall be observed. Hence, finance staff will be allowed to bring home equipment such as computer, printer, and the likes necessary to carry out their tasks during their Work-From-Home (WFH) schedule. This matter should be properly coordinated with the designated Supply Officer/Property Custodian.
- 4. Accomplished report will be submitted online to the respective Senior Bookkeepers assigned to each District for checking. This report submitted to the District Senior Bookkeepers, in PDF form and originally signed, will then be submitted to the Senior Bookkeeper on site in the Division Office. Accomplished report signed using e-signature will be accepted provided that is submitted with a certification letter (Enclosure 3).
