

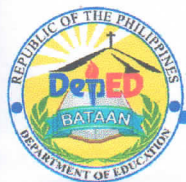
EXTENSION OF ENROLLMENT PERIOD FOR SCHOOL YEAR 2021 - 2022

Private schools, state colleges and universities, including local universities that are following the school opening schedule of DepEd are highly encouraged to also accept late enrollees until the extension date.
3. This DepEd Order shall take effect immediately upon its issuance and shall be registered with the University of the Philippines Law Center-Office of the National Administrative Register (UPLC-ONAR), UP Diliman, Quezon City.
