With the advent of global interdependence and the advancement of technology, education becomes sufficiently inconclusive.

The need to globalize trade and services, market and even education is one of the backbones of establishing ASEAN integration. ASEAN Integration also gives member nations to do more trade for goods and services. Tax on imported goods is lowered or even eliminated. If fully implemented, talking about ASEAN Economic Community could mean lower taxes and tariffs for imported goods, and in turn, could lead to a lower cost of living and greater purchasing power for the Philippines.

Also, Filipinos would have more access to better jobs if they are better equipped for these emerging roles. Thankfully, even the country's education would be enhanced because of ASEAN integration. For instance, last August 2017, Canada's Minister of Foreign Affairs announced at the ASEAN regional forum in Manila that they would be offering a \$10 Million Scholarship Program to support post-secondary students and mid-career professionals from Southeast Asia. The National University in Singapore offers scholarships for ASEAN countries for graduate coursework. These are only a few examples of quality international support for Filipino students.
