This Office informs all concerned that the Teacher Dignity Coalition (TDC) will hold a **National Consultation-Training for Teachers** on **April 29-May 1, 2023** at **Benitez Hall of Baguio Teachers' Camp**.

The participants are 700 teachers, school administrators, academic personnel, and other education workers and advocates from the 17 regions of the country. A registration fee of Php4,200.00 will be collected for each participant to cover expenses for board and lodging, kit, materials, speakers' honoraria, and other incidental expenses chargeable against local funds or LGU assistance.

The objectives of the said activity are as follows:

- Discuss the existing national policies evolving the rights of teachers as well as the welfare of the children;
- Provide the teachers with information on pertinent issues of the education sector and solicit more proposals for a better and improved education system;
- Equip the teachers and school administrators with knowledge and skills to make them more responsible teachers and education leaders; and
- Formulate police recommendations in response to current issues and concerns.

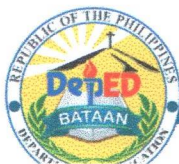

Greetings of Peace!

The Teachers Dignity Coalition (TDC) will hold a *National Consultation-Training for Teachers* on April 29-May 1, 2023 at the Benitez Hall of Baguio Teachers' Camp. The activity will coincide with the organization's 5th National Convention and the celebration of its 17th Anniversary. The theme for the activity is "**Pagkakaisa at Pagmamalasakit Para sa Guro, Para sa Bata, Para sa Matatag na Edukasyon.**"

This very significant event will be attended by some 700 teachers, school administrators, academic personnel, and other education workers and advocates from the 17 regions of the country. The objectives of the activity are as follows:

- Discuss the existing national policies involving the rights of teachers as well as the welfare of the children;
- Provide the teachers with information on pertinent issues of the education sector and solicit more proposals for a better and improved education system;
- Equip the teachers and school administrators with knowledge and skills to make them more responsible teachers and education leaders; and
- Formulate policy recommendations in response to current issues and concerns.

Each participant shall be charged a minimal contribution/registration fee of four thousand two hundred pesos (P4,200.00) to cover expenses for board and lodging, kit, materials, speakers' honoraria, and other incidental expenses. We have sent a formal request to the DepEd to allow such expenses to be charged against available local funds. Pending the approval, however, our delegates also have the option to raise funds from private sponsorship of LGU assistance.
