- 1. The Schools Division Office of Bataan announces the conduct of Presentation Portfolio Assessment (PPA) Year 4 for ALS Elementary and Junior High School learners for School Year 2022-2023.
- 2. The activity aims to:
 - a. Validate the Learner's Portfolio (LP) as basis for completion;
 - b. Identify learners eligible for completion; and
 - c. Facilitate the issuance of Elementary and Junior High School Level Certificate of Program Completion to ALS completers.
- 3. The step-by-step process of the Presentation Portfolio Assessment is as follows:

Activity	Date
 Phase I – Initial Assessment – ALS teachers check the completeness of the work samples and formal records. 	April 20 - 30, 2023
 Phase II – District Validation – ALS teachers within the District validate the submitted presentation portfolio. 	May 1 - 15, 2023
 Phase III – Final Assessment – EPSAs conduct the final assessment. 	May 16 – June 15, 2023
 Phase IV – Inter-District Revalida – EPSAs conduct the oral reading, writing proficiency tests and interview. 	June 15 - July 15, 2023
