2023 REGIONAL INVENTION CONTEST RULES AND CRITERIA (BY CLUSTER)

1. Rationale

The Regional Invention Contest and Exhibits (RICE) is a nationwide activity conducted by the Technology Application and Promotion Institute of the Department of Science and Technology (DOST-TAPI) in different regions to recognize the indispensability of the Filipino inventors in the Philippine society and in the landscape of national economic development. The Regional Invention Contest (RIC) shall encourage inventors to utilize their innovativeness through competition and with prizes to look out for. RIC serves as the qualifying round for the National Invention Contest, pursuant to Section 4 of the Republic Act (RA) No. 7459 also known as "Inventors and Invention Incentives Act of the Philippines".

For CY 2023, the competition shall be conducted through clusters instead of per region or ClusteRICE. The five (5) Clusters shall be as follows:

- a. National Capital Region (for Cities and Municipalities within the NCR);
- b. Southern Luzon (for Region IV-A, IV-B and V);
- c. Northern Luzon (for Region I, II, III and CAR);
- d. Visayas (for Region VI, VII and VIII); and
- e. Mindanao (for Region IX, X, XI, XII, XIII and BARMM).

2. Invention Contest Categories

The invention contest for this year is open to both the public and private sector inventors and researchers within the Regions of the Clusters. There are five (5) categories where talented Filipinos can compete in the invention contest, namely:

- a. Outstanding Invention (Tuklas Award);
- b. Outstanding Utility Model (Unlad Award);
- c. Outstanding Industrial Design (Banghay Award);
- d. Outstanding Creative Research (Likha Award); and
- e. Outstanding Student Creative Research (Sibol Award) for High School and College students.
- 2.1 Invention Category: Invention refers to any technical solution of a problem in any field of human activity which is new, involves an inventive step and is industrially applicable. It may be, or may relate to a product, or process, and their improvements, (Sec. 21, RA 8293). It shall be covered by invention patent still in force granted by the Intellectual Property Office of the Philippines (IPOPHIL).
- 2.2 Utility Model (UM) Category: Utility Model refers to any technical solution of a problem in any field of human activity which is new and industrially applicable, within contemplation of the above statute (Sec. 109, RA 8293). It shall be covered by utility model registration with a valid registrability report still in force granted by (IPOPHIL).

- 2.3 Industrial Design (ID) Category: Industrial Design refers to any composition of lines or colors or any three—dimensional form whether or not associated with lines or colors: Provided, that such composition or form gives a special appearance to and can serve as pattern for an industrial product or handicraft within the contemplation of the above statute (Sec. 112, RA 8293). It shall be covered by industrial design registration with valid registrability report still in force granted by the (IPOPHIL).
- 2.4 Creative Research Category: Creative Research refers to patent pending inventions, registration pending utility models and industrial designs and research results not yet applied for patent, utility model and industrial design registration. Eligible under this category are new and useful machines or devices or gadgets, products or processes or an improvement of any of the foregoing; and non-biological or microbiological processes not contrary to public order, morals, public health and welfare. These are research results with demonstrable qualities and potential for improvement and/or widespread commercialization or dissemination. The Creative Research Category (Likha Award) shall be sub-categorized into (a) Government-Funded and (b) Privately-Funded if there are at least three (3) qualified entries in both sub-categories. However, if entries on either of the sub-category is less than three (3), the two (2) sub-categories shall be merged into one (1) category only.
- 2.5 Student Creative Research Category (Sibol) Category: Student creative research refers to new and innovative projects or models developed by students in secondary and tertiary levels. These projects or models should possess features and characteristics that may have significant contributions to the promotion of Science and Technology (S&T) innovations that are not contrary to public order, morals, public health, and welfare. The category will be sub-categorized into Student Creative Research for College and Student Creative Research for High School.

3 Invention Contest Eligibility

- 3.1 The contest is open to all inventors, makers, designers, creative researchers and student researchers who are Filipino citizens residing in the Regions belonging to the respective regional Cluster. They are eligible to join in any of the five (5) categories of the invention contest as stated above and compete for awards and represent the Cluster Region in the National Invention Contest. However, an entry in any of the categories may be entered in only one (1) Cluster invention contest during the year.
- 3.2 For the purpose of eligibility, a contestant is considered a resident of the region belonging to the respective Cluster, if he or she has met any of the following:
 - a) He or she is actually residing and has six (6) months residency in the region belonging to the respective Clusters; and
 - b) He or she has principal office address or enrolled in a school within the said region belonging to the respective Cluster.

3.3. The Outstanding Student Creative Research Category or Sibol Award is open to high school and college students. Entries should be duly endorsed by the school wherein the contestants are students and where the creative research was done. The endorser can either be the principal, the school head, and the dean of the college or the president of the school or university.

- 3.4 The Out-of-School Youths (OSYs) are eligible to join either in the Creative Research Category or the Student Creative Research Category. Entries should be duly endorsed by the local inventor's organization in the region belonging to the respective Cluster.
- 3.5 The inventions, registered UM and ID, creative research or a student creative research that have won in previous Regional or National Invention Contests shall no longer be eligible to join in subsequent National or Regional Invention Contests in the same category. However, those entries that have won under the Creative Research and Student Creative Research Categories may join the invention contest, provided that such entries are now patented or registered at the IPOPHL.
- 3.6 Entries in the invention, UM and ID categories must already have patent, UM, and ID registrations, respectively, on or before the deadline for the submission of entries.
- 3.7 Only the inventors, makers and designers whose names appear in the patent, UM and ID registration documents, respectively, may join in the contest. In case of an invention, a UM or an ID by a group, all members must sign in the accomplished entry forms, or sign waivers and other documents if they are not joining the contest.
- 3.8 Disqualification of one (1) member would mean disqualification of the other members in joining the contest. If an entry is qualified in more than one (1) Cluster they could only choose to join in one (1) Cluster.
- 3.9 In case of joint ownership in a certain invention or research, all of the inventors, makers, designers and creative researchers must possess the eligibility requirement as stated in Item number 3.2 of this Contest Rules and Criteria. Disqualification of one member would mean disqualification of the other members in joining the contest. If an entry is qualified in more than one region, they could only choose to join in one region.

4 Invention Contest Requirements and Mechanics

4.1 For the qualifying round, contestants are required to submit the entries to the following invention contest links:

- 4.2 All entries with complete requirements will be forwarded to the Board of Judges (BOJ)on the respective cluster regions for judging and deliberations.
- 4.3 The BOJ will select the top ten (10) qualified entries per category/sub-category which may decrease depending on the number available qualified entries but in no case be less than 3 entries per category or sub-category.
- 4.4 The top ten (10) qualifiers will be informed by ClusteRICE secretariat to submit the following requirements:
 - 4.4.1 One (1) copy of the completely filled-up and notarized entry forms including:
 - RIC Form No. 01 Entry Form for invention, UM, ID and creative research categories, herein attached as ANNEX 1; and
 - RIC Form No. 03 Entry Form for Sibol Award, herein attached as ANNEX
 2.
 - 4.4.2 One (1) original copy of signed and notarized waivers:
 - RIC Form No. 02 Waiver Form for invention, UM ID, and creative research categories, herein attached as ANNEX 3; and
 - RIC Form No. 04 Waiver Form for Sibol Award, herein attached as ANNEX 4.

- 4.4.3 One (1) copy of letters patent or UM or ID registration (as applicable).
- 4.4.4 One (1) copy of one (1) page abstract, description or drawings, pictures, certificates.
- 4.4.5 One (1) original copy of notarized Certification that their work is their own, new and original, for Creative Research Category (Likha Award) and Student Creative Research Category (Sibol Award):
 - RIC Form No. 5 Certification for Entries under the Creative Research Category (Likha Award), herein attached as ANNEX 5; and
 - RIC Form No. 6 Certification for Entries under the Student Creative Research Category (Sibol Award), herein attached as ANNEX 6.
- 4.5 All certifications and waivers or contest forms must be under oath and subscribed into by the affiants except for underage students must be signed by their legal guardian herein attached as ANNEX 7.
- 4.6 The contestants must submit their duly accomplished entries to the respective DOST-RO, DOST-TAPI or directly through the inventions contest link stated in Item 4.1. The DOST-TAPI will pre-screen entries based on compliance to the requirements stated in Item 4.1 of this Rules and Criteria. All documents submitted are subject to final examination by the Board of Judges.
- 4.7 For Student Creative Research Categories (College and High School), the advisers are not allowed to make presentations in behalf of their students.
- 4.8 The contestants may be required to provide additional information to the Judges in order to facilitate the evaluation of their entries during the contest proper.
- 4.9 The top qualifiers per category as mentioned above will be requested to pitch their entry during the event, schedule will be provided by ClusteRICE Secretariat.
- 4.10 The contestants in the Creative Research Categories (Likha Award and Sibol Award) shall agree that any intellectual property included in their entries shall be protected under the DOST-TAPI's Intellectual Property Rights Assistance Program (IPRAP). Ownership shall be retained by the contestants or their Assignees, if applicable, who shall also disclose their creative works in full.
- 4.11 All ClusteRICE winners under the Creative Research Categories (Likha Award and Sibol Award), as a requirement for the National Invention Contest, shall automatically avail DOST-TAPI's IPRAP.
- 4.12 The First Prize Winners of the Creative Research (SIBOL) Category will be featured in the National Science, Technology and Innovation Youth Festival on 25-28 October 2023.

4.13 All contestants and ClusteRICE winners shall commit to push for the commercialization of their inventions and researches once opportunities are provided.

5 Judging and Criteria

5.1 Board of Judges

The Board of Judges is composed of highly qualified professionals thoroughly selected by the DOST-TAPI **ClusteRICE** Awards Committee. The judges must not be affiliated with any organizations, agencies, schools, or universities of the participating contestants in the regional contest of the same year. The judges must sign a Non-Disclosure Agreement (NDA) with DOST-TAPI prior to judging, herein attached as **ANNEX 9**

5.2 Judging Criteria

5.2.1 Qualifying Round

All entries initially evaluated by DOST-TAPI in terms of completeness of documentary requirements will be endorsed to the Board of Judges (ANNEX A). The judging criteria per category to be observed by the Board of Judges are as follows:

- 5.2.2 There will be two rounds of judging: the qualifying (paper presentation) and final rounds (with presentation). In the qualifying round, the Board of Judges will shortlist the top ten (10) entries per category or sixty (60) entries per cluster that will compete for the ClusteRICE;
- 5.2.3 Should there be any information that needs clarification from the Board of Judges, the DOST-TAPI RICE Secretariat shall coordinate with the contestant to verify the information in the entry form submitted.

5.2.4 DOST-TAPI will send invitations to the qualifiers per category and provide a format of presentation.

5.3 Final Round

5.3.1 All the qualifiers scores will be back to zero percent. All the categories that will compete for the ClusteRICE will be judged according to the following criteria:

- 5.3.2 For the Student Creative Research Category, the advisers are not allowed to answer the Board of Judge's inquiries on behalf of their students.
- 5.3.3 The contestants may be required to provide additional information to the judges in order to fully evaluate their entries during the contest proper.
- 5.3.4 The DOST-TAPI ClusteRICE Secretariat will create an online platform that will hold the regional exhibit by cluster. A virtual booth will be assigned to each finalist, to display their official entries. Each entry shall be provided by an official collateral designed by DOST-TAPI. The virtual booth assignment is segmented per category.
- 5.3.5 The decision of the Board of Judges is final and unappealable. The scorecards or rating sheets are considered personal notes of the judges and are not for public scrutiny. Thus, any part of it must not be given to any contestant or requesting party.
- 5.3.6 No entry shall be declared as 1st, 2nd or 3rd place winner in any category or sub-category unless the same garnered an overall rating of 80%.
- 5.3.7 The contestants or their duly-designated representative shall release, hold free from any responsibility, and waive whatever cause of action which they have or may hereafter have against the members of the Board of Judges, the DOST-RO, the DOST-TAPI, and their employees, that may arise from or relative to the conduct and result of the Contest as reflected in RIC Form 02 and RIC Form 04 (ANNEXES 3 and 4). No entry shall be considered officially entered in the contest unless the contestant and their witnesses have signed the waiver and submitted the signed waiver to DOST-TAPI or DOST RO.

6 Announcement / Awarding of Prizes

6.1 Winners shall be selected per category or sub-category, if applicable. In case of tie, the Board of Judges shall break the tie via majority vote and declare only up to three (3) ClusteRICE winners per category or sub-category. The first prize ClusteRICE winner in each category shall automatically be the national qualifier and Finalist for the National Invention Contest.

6.2 All ClusteRICE winners shall receive a cash incentive and certificate of recognition during the Awarding and Closing Ceremonies.
