iSpy Arts and Science Exhibit is divided into 4 galleries

GALLERY 1 - JUNK ART

At its core, recycled art is about repurposing materials and nature conservation. The underlying message behind all recycled art is in the title itself: recycle. Though each piece has meanings and themes that vary greatly, at its heart the notion of repurposing supplies into sculptures sends a strong message on its own...that we should follow suit. As long as the materials used in the piece were discarded, there's really no limit to what can be used and what the pieces can look like. They can vary from large scale to miniature, from two-dimensional pieces to three dimensional. It's a growing movement but, though its popularity has surged recently, it isn't an entirely foreign concept. The environmental benefits of recycled art include, for example, its contribution to the use and extending the useful life of materials and, as a consequence, by reducing the amount of waste generated. It takes a great deal of creativity and a degree of technique to work with these materials.

GALLERY 2 - OPTICAL ILLUSSION

Optical illusions teach us how our eyes and brain work together to see. We live in a three-dimensional world, so our brain gets clues about depth, shading, lighting, and position to help us interpret what we see. We see by learning how to see. Our brains have evolved to identify patterns, creating associations by interacting with the real world. It's a survival instinct to fully understand how optical illusions work, it's important to grasp that the visual system is made up of more than just our eyes. In fact, optical illusions don't necessarily trick our eyes—they trick our brains.

GALLERY 3 - SCIENCE EXPERIMENT

Science experiments generate deep interest in young minds of students. Students endeavor to comprehend every activity they are engaged in by asking questions and seeking answers. Experiments provide learners with hands-on experiences that are not found elsewhere than by doing specific tasks themselves rather than just passively absorbing information through reading or listening. Science experiments are a great way for students to learn about the world and develop their skills in this area. The opportunity to design and execute their own experiments also helps students develop a sense of ownership which in turn encourages them to take more responsibility for what they learn, as well as have fun trying things out on their own. These science exhibitions encourage students to think out of the box and be creative and inventive. It makes them enjoy science and just not take it as a mere subject. Students are able to come up with their own ideas.

GALLERY 4 - 3D MOVIE


3D Video (3D glasses are provided) Orientation plays an integral role in the ongoing success and growth of any event, regardless of niche or sector, yet many exhibitions overlook this essential part of the short on-boarding process. The primary aim of the orientation efforts should be to make all the participants feel like a valued part of the exhibit, not just a mere spectator or audience but a contributor. The 3D films can give stunningly effective movie experience and spark the senses while giving emotional arousal, which in turn makes the brain run faster and smarter. Now that the 3D films come with a whole lot of benefits. In 2015 in UK a group of scientists and doctors conducted an experiment about 3D films participating filmgoers showed a 23% increase in cognitive processing ability after watching a movie in stereoscope. Their reaction times improved by 11%, and they experienced a "brain boost" for up to 20 minutes after viewing. The improvement in reaction time was five times that experienced by participants who had been watching a 2D movie. The initial results of this study indicate that 3D films may potentially play a role in slowing this decline. Scientists and Doctors believe 3D movies could be used to help improve the performance of surgeons and other professionals requiring superlative cognitive brain function.

REGIONAL MEMORANDUM No. 621, s. 2022



CO-CURRICULAR ACTIVITIES THAT ARE ALLOWABLE TO BE CONDUCTED STARTING SCHOOL YEAR 2022-2023

To: Schools Division Superintendents
Curriculum Implementation Division Chiefs
Education Program Supervisors
Public Schools District Supervisors
Public Elementary and Secondary School Heads
All Others Concerned

- 1. This is relative to Department of Education Order (DO) No. 34, s. 2022, where it is stated that School Year 2022-2023 shall consist of 203 school days and this number of school days shall solely be dedicated to academics/curricular activities and related co-curricular activities. The conduct of extra-curricular activities shall be strictly prohibited.
- The following are defined in the mentioned DO and taken from DO 21, s. 2019 to avoid confusion:
 - a. Curricular Activities are opportunities and experiences undertaken by the learners in the classrooms, laboratories, workshops, and homes as well as school-based and out-of-school activities conducted to ensure the learners' acquisition of the K to 12 learning standards and the 21st -century skills;
 - b. Co-curricular Activities are authorized, voluntary, and non-graded engagements, whether on or off-campus, that reinforce the development of 21st -century skills beyond the scheduled contact time between teachers and learners. The activities must be anchored on the curriculum's content and performance standards. They are considered an extension of formal learning experiences and are provided to tap into and enrich the varied intelligences and skills of learners; and
 - c. Extra-curricular activities are also voluntary, non-graded learner engagements that are not anchored on the content and performance standards in the curriculum and are offered/coordinated by the school to promote the learner's holistic development.
- 3. Schools are encouraged to integrate the celebrations/observances provided for by law in Enclosure No. 3 of DO 34, s. 2022, into curricular activities that may be undertaken in the classroom, as they deem reasonable and appropriate, so long as the total number of school days shall not be compromised.
- 4. It is reiterated that pursuant to the objectives of Sulong Edukalidad, as stated in DO 34, s. 2022, schools shall strictly devote 10 weeks of every academic

quarter to actual classroom teaching. The eleventh week of each quarter may be used for the conduct of co-curricular activities.

The following are the co-curricular activities that can be conducted:

a. Scouting

- b. Press Conference
- c. Science and Technology Fair
- d. Festival of Talents
- e. Sports

Culminating Activities in Different Learning Areas f.

- g. Activities relative to Supreme Pupil Government (DO 45, s. 2007, re: Institutionalization of the Supreme Pupil Government in All Elementary Schools Nationwide)
- h. Activities relative to Supreme Student Government (DO 49, s. 2011, re: Mandated Programs, Projects, and Activities of the Supreme Student Government)
- School Heads shall prepare a school calendar to reflect the co-curricular activities for the entire school year for the approval of the concerned Schools Division Superintendent.
- Other co-activities that are not cited in Item No. 5 shall be allowed provided 7. that:
 - there are learning standards (content standard, performance standard, and learning competencies) where the activities can be anchored;

b. the activities shall be held outside class hours, on weekends, or during school breaks;

- c. the learning standards where the activities can be anchored are checked/validated and recommended for approval by the Division Learning Area Education Program Supervisors and approved by the Schools Division Superintendents; and
- d. the approved activities are included in the school calendar prepared by the school head in Item No. 6.
- Beauty contests and other related activities that are conducted for the sake of fundraising are strictly prohibited.
- Educational Field Trips/Tours shall be allowed provided that the organizer(s) shall strictly adhere to the DO 66, s. 2017, titled "Implementing Guidelines on the Conduct of Off-Campus Activities.
- Service credits for teaching personnel and Compensatory Time-Off (CTO) for non-teaching personnel will be granted in lieu of the activity/workshop days that will fall on either holidays or weekends per DO 53, s. 2003, titled Updated Guidelines on Grant of Vacation Service Credits to Teachers, and Civil Service Commission-Department of Budget and Management Joint Circular No. 2, s. 2015, re: Policies and Guidelines on Overtime Services and Overtime Pay for Government

Employees, respectively. In addition, pursuant to DepEd Memorandum No. 065, s. 2021, one workday of vacation service credit shall be granted per accumulated eight hours of service rendered. Moreover, under this mentioned Memorandum, the 15-day limitation under DO 53, s. 2003, is suspended to allow teachers to claim service credits exceeding 15 days.

- The provisions of this Memorandum shall be in effect immediately and shall remain in force until revoked or rescinded.
- 12. Wide dissemination of and compliance with this Memorandum is desired.
