Del Mundo and Refozar (2017) assert that in order to carry out their duties and fulfill their roles as knowledge providers in a constantly changing and more competitive professional environment, instructors must increase their capacity to disseminate current information. The subject matter of the curriculum and its use of instructional modalities must be updated to reflect the changes in the local and global labor markets' job needs. Therefore, in order to adapt to the demands of the modern labor market, higher education institutions must alter course and create more effective teaching methods. It is crucial for educators to be up to date on what will be expected of them in terms of relevance and functioning in the future. In order for students to effectively contribute to the organizational goals and targets, teachers are thought to need to develop their potential, better their knowledge and skill sets, and change their behavior and attitude toward learning.

They also support students' academic work and professional development. Thus, improving the teaching-learning process in the classroom requires addressing the competencies of the teachers.
