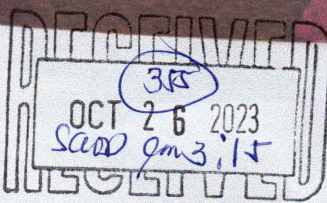

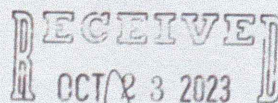

Greetings of Peace and Solidarity!

We wish to thank your good office for approving ASSERT CL Union's request in issuing the Division Advisory 206, s. 2023 to make the participation of Teachers during the conduct of a Division and District-wide fora on the upcoming Run-Off Elections among the rank and file teaching personnel of DepEd Region 3 on Official Time.
