With a few exceptions, the Data Privacy Act applies extensively to persons and legal entities that process personal information. The law has extraterritorial effect, meaning it applies not just to businesses having headquarters in the Philippines, but also when processing equipment situated in the Philippines is employed. The Act also applies to the processing of personal information of Filipino nationals, regardless of where they live, since as a Filipino citizen, there's no exemption when it comes to data privacy. One good instance is that the law does not apply to the processing of personal information in the Philippines that was properly collected from citizens of other countries. — a useful provision for Philippines-based cloud service providers.

With this legislation, institutions will be protected by law and will focus on the idea that "the processing of personal data shall be allowed subject to adherence to the principles of transparency, legitimate purpose, and proportionality." It is imperative that every member of an organization is well aware of this act to assure that they are not being baited or scammed.
