Greetings of peace and gratitude!

I am writing to inform you of important developments regarding the loan amnesty granted to teacher members, and to seek your assistance in disseminating this information to all supervisors and principals within the Division of Bataan. The loan amnesty, initially implemented from March 2023 to December 31, 2023, has officially concluded.

I wanted to update you on the amount collected from the old loans. We have successfully collected the amount of Php 530,040.11 so far.

However, due to the substantial volume of messages and calls received, and recognizing the challenges faced by our members, the executive board has decided to extend the amnesty period for another three months. This extension will be effective until March 31, 2024. Moving forward, borrowers and our office will be required to enter into a written agreement if payments cannot be made by March 31, 2024. In the event of non-payment by April 1, 2024, the proper interest, as mandated by Private Lending Institutions (PLIs), will be applied.

Additionally, we are offering borrowers the option to renew their loans through the Automatic Payroll Deduction System (APDS) to facilitate smoother transactions.

I kindly request your assistance in disseminating this information to all the supervisors and principals under the Division of Bataan.
