Students perceived that their learning success was related to the teachers' code-switching.

Another study conducted by Pollard proved that students who could freely codeswap within the classroom encountered fewer linguistic hurdles when discussing the topic matters. As a result of the verbal freedom provided by code-switching, learners were better able to share the information they gained with teachers or classmates.

Conversations between students who were not allowed to code switch ineffectively were frequently choppy, and they could not utter words they wanted to express. It supports the idea that although structural grammar teaching is ideal, code-switching can make a big difference.

In multilingual societies, individuals who can code-switch effectively may have advantages in accessing job opportunities and navigating diverse professional environments. Lastly, Individuals who code-switch regularly may demonstrate enhanced cognitive abilities related to language processing and executive functions.

While code-switching can have several advantages, it is also essential to be aware of potential disadvantages, depending on the context and the individuals involved. While it can have various benefits, it is also necessary to consider the context and appropriateness of code-switching in different situations.
