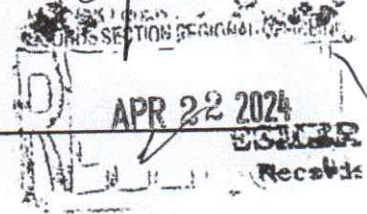

FULL SCHOLARSHIP AT UNIVERSITY OF HAIFA, ISRAEL

With reference to the communication from the Embassy of Israel, this Office issues this Advisory for the University of Haifa scholarship on International Master of Arts Program in Education and Development in Early Childhood.

The program is taught in English and collaborates with MASHAV – Israel's Agency for International Development Cooperation, Ministry of Foreign Affairs.

Full scholarships and living stipends will be granted to eligible students arriving from under-resourced countries. The scholarships include coverage of tuition, housing, medical insurance and living expenses.

Applications for the scholarship must be submitted not later than May 1, 2024, via the Impact for Good Scholarship application form which may be accessed through <https://www.studyinhaifa.com/earlyeducationandscholarship>.

Decisions regarding acceptance will be released on June 15, 2024.
