**CALL FOR APPLICATION FOR THE NATIONAL
LEARNING CAMP VOLUNTEERS**

1. In view of the implementation of the National Learning Camp (NLC) and Other 2024 End-Of-School-Year (EOSY) Break Activities in Support of the National Learning Recovery Program (NLRP), which is scheduled for **July 1-19, 2024**, this Office through the Curriculum Implementation Division (CID), calls for the **Submission of Application for the Learning Camp Volunteers (LCVs) starting June 17-21, 2024**.

2. Applicants shall submit documentary requirements to the Division Sub-Committee headed by the PSDS, who shall be responsible of evaluating based on the following eligibility requirements, to wit:

- DepEd Incumbent teachers
- Remaining LET- eligible applicants in the recent and/or previous Registries of Qualified Applicants (RQAs) who are not given appointments
- Other LET- eligible individuals in the locality, such as, but not limited to, teachers from private schools/SUCs/LUCs, and other teaching practitioners in the community
- Other LET- eligible teacher applicants in the above-mentioned RQAs who did not meet the cut-off score per existing DepEd hiring guidelines.

3. Only the eligible applicants who meet the minimum and preferred qualification shall undergo the assessment and selection process to be conducted by the Learning Camp Volunteer (LCV) Sub-Committees on June 26-27, 2024. The lists of consolidate lists of applicants who meet the eligibility requirements shall be consolidated using the Assessment and Selection Report and submit to this Office on June 28, 2024.
