DIVISION ADVISORY No. 204, s. 2024

To: Public Schools District Supervisors Elementary School Principals Public Secondary School Principals All Others Concerned

This Office informs all concerned that the Diocesan Catechetical Ministry of the Catholic Church, will be holding catechism classes in public elementary and secondary schools starting this September 2024.

The field is reminded of the provisions of DepEd Order No. 49, s. 2009 titled "Reiterating the Revised Rules and Regulations on the Teaching of Religion in Public Elementary and Secondary Schools".

No. 1 - (d) of the said Order states:

"The religious teachers/instructors who teach religion classes in the public elementary and high schools shall be formally sourced or recruited by the respective principal or school head in accordance with the corresponding request for optional religious instruction. After their designation or nomination by their respective religious authorities, said teachers shall submit to the school head their proper authorization papers and request for time allocation and schedule for the optional religious instruction."

No. 1 - (e) further states at the last part:

"No student/pupil shall be allowed or permitted to attend religious instruction classes without written application and duly accomplished request of his/her parent/guardian."

No. 1 - (j) of this Order also clarifies that:

Optional religious instruction and Values Education are separate, different, and distinct subjects. As such they shall be allotted separate class hours...
