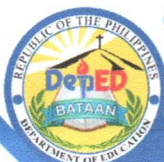

5. RULES AND CONSTITUTION COMMITTEE

The Rules and Constitution Committee will oversee the creation, amendment, and enforcement of the DFSSLG’s governing documents.

6. PUBLIC RELATIONS COMMITTEE

The Public Relations Committee will manage the DFSSLG’s image and reputation, ensuring clear and effective communication with the student body and the public.

7. MULTIMEDIA COMMITTEE

The Multimedia Committee will be responsible for creating and managing digital content, including social media, videos, graphics and documentation, to promote the activities and initiatives of the DFSSLG.
