1. This Office announces the National Learning Camp Program Implementation Post Assessment Strategies and Feedback Mechanisms for Curriculum Development on August 8, 2024 at Sinagtala, Tala, Orani, Bataan.

- a. identify key strategies for effective planning and execution of learning camps, and share best practices in learning camp implementation from 12 districts;
