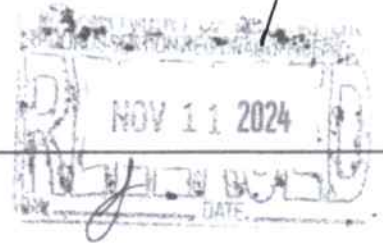

practice assessments designed to build domain-specific competencies and familiarization with PISA-Aligned Questions:

- a. R3-PISA-LDW: Learning in the Digital World
- b. R3-PISA-SCI: Scientific Literacy
- c. R3-PISA-READ: Reading Literacy
- d. R3-PISA-MATH: Mathematics Literacy

5. Schools with identified 15-year-old students from grades 7 to 10 shall take the 5 to 10 questions per component per day through the DepEd LMS from **November 11, 2024 to December 13, 2024** to familiarize students with PISA-type questions and computer-based assessment format through structured practice.

6. School heads through the assistance of the School Testing Coordinators may strategize the scheduling of the learners based on their availability.

7. Division Testing Coordinators, School Testing Coordinators, PISA Technical Working Groups (TWGs) in the Division and District Levels are advised to monitor the utilization of the Region III PISA-Aligned Assessment Program through the DepEd-LMS and shall provide technical assistance, if needed.

Implementation Guidelines

I. Program Context and Integration Framework

A. Background

The Region III PISA-Aligned Assessment Program is a strategic initiative developed by DepEd Region III to enhance Filipino students' preparedness for the 2025 Program for International Student Assessment (PISA). This program systematically integrates PISA-type questions and assessment methodologies into classroom instruction, enabling students to build essential skills in Science, Mathematics, Reading, and Digital Literacy.

The goal of PISA is to evaluate education systems worldwide by testing the skills and knowledge of 15-year-old students, who are approaching the end of their compulsory education. PISA tests how students can apply their knowledge to real life situations and problems, rather than testing knowledge recall. Every three years, participating countries assess their 15-year-olds in three cognitive domains: Reading, Mathematics, and Science; and in PISA 2025, **Science** is the major domain, and **Learning in the Digital World** is an innovative domain, which will be administered through a Computer-Based Assessment (CBA) scheme.

Through this program, students engage in real-world problem-solving and critical thinking activities that mirror PISA's standards, encouraging a cross-curricular approach to skill development. The program's framework includes using the DepEd Learning Management System (LMS) to support consistency in assessment practices across subjects, ensuring that learners gain comprehensive exposure to globally relevant competencies. Through embedding these practices within the regular program, the DepEd Region III aims to foster lifelong learning skills essential for student success in a global context.

B. Integration

The PISA-Aligned Assessment Program integrates key activities into regular classes to build critical thinking and problem-solving skills. Below are the guidelines for implementation.

1. Curriculum Integration

- Teachers shall embed PISA-aligned activities within their regular class program by taking or administering 1 quiz activity/practice assessment per component.

- The minimum of two (2) periods per week shall be dedicated to PISA-type questions and activities.
- Integration should focus on real-world applications and problem-solving scenarios that are aligned with PISA Content Knowledge as given in the DepEd LMS and other materials.
- Subject departments should collaborate to ensure cross-curricular implementation.

2. Learning Session Components

- PISA-aligned question practice (10-20 minutes)
- Reflection and discussion of the Quiz (15-20 minutes)
- Retake of PISA-aligned Question (10-20 minutes)

3. Required Practice Hours

- Students must complete a minimum of 4 hours' weekly practice across all domains
- Distribution of practice hours:
 - Science: 2 hours (major domain)
 - Mathematics: 1 hour
 - Reading: 1 hour
 - Learning in Digital World: 1 hour (integrated across subjects)

C. Roles and Responsibilities

The effective implementation of the PISA-Aligned Assessment Program relies on the collaborative efforts of school leadership, teachers, and students, each of whom plays a distinct role in promoting a consistent and supportive learning environment. Below are the roles and responsibilities.

A. School Leadership

1. School Heads

- Ensure integration of PISA practice in master schedule
- Monitor teacher compliance and student participation

B. Required Credentials

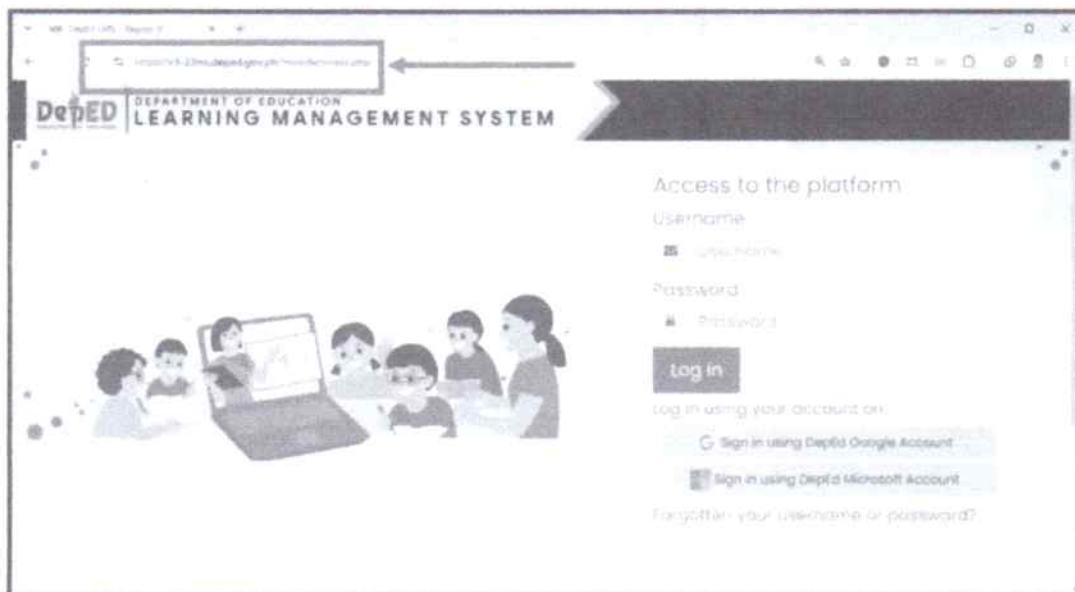

Did you know that water currents in the northern Pacific Ocean capture a huge amount of garbage? Plastic and other types of man-made waste float on the surface and circulate below the water. It is difficult to measure how much trash is in the ocean because a lot of the trash is broken down into tiny pieces. As a result, this polluted region is more like "trash-soup" than a solid "island of trash" that is easy to see. Some reports estimate that this area, known as the Pacific Garbage Patch, covers 700,000 square kilometers (270,000 square miles), while others say the area is as big as 15,000,000 square kilometers (5,800,000 square miles).

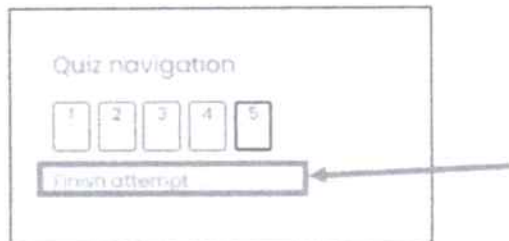

E. Repeat Process for Each Component

- Students may proceed to attempt other activities and quizzes also with other PISA components.
- Each component can be repeated multiple times for practice and improvement.
- No limit on number of attempts per quiz or component since the aim is to immerse and familiarize learners.

Teachers can monitor student progress through their teacher accounts in the LMS, which provides access to student reports on each component as long as they enroll themselves as teacher in course. While the LMS serves as the primary monitoring tool, teachers may also implement alternative recording methods such as spreadsheets, or templates to track student scores.
