The first is the distribution of resources: Many schools lack the funds and materials required for successful inclusive practices. Third, the focus on standardized testing may exclude kids with special

learning needs, resulting in a curriculum that is more limited and less possibilities for inclusive participation.

In addition to respecting each student's rights, we enhance everyone's educational experience by fostering inclusive settings. A more creative, empathetic, and connected society can result from embracing diversity in educational environments.
