- 1. This Office announces the Division Sports Competition, themed "Championing Excellence: Elevating Skills and Sportsmanship," to be held at various venues on January 8 10, 2025.
- 2. The objectives of the event are as follows:
 - Identify and select outstanding team sports athletes who exhibit exceptional skill, dedication, and sportsmanship.
 - Foster a competitive spirit and enhance performance standards by providing a platform for athletes to demonstrate their abilities and refine their skills.
 - Boost student engagement and enthusiasm in sports by creating opportunities for active involvement and achievement in their disciplines.
 - Improve the standing of the Schools Division Office of Bataan in sports rankings by nurturing top-performing athletes and achieving superior results in competitions.
- 3. All districts shall organize their respective athletic delegation comprising the best student-athletes and coaches from both public and private schools.
- 4. The eligible birth years for student-athletes are as follows:
 - Elementary January 1, 2012
 - Secondary January 1, 2007

- 5. The required documents to be submitted include:
 - Medical Certificate issued by the SDO Medical Officer;
 - Photocopy of the PSA birth certificate/Local Civil Registry; and
 - Parental Consent.
- 6. The District Selection shall be held after class hours. The procedures outlined in DepEd Order No. 9, s. 2005, titled "Instituting Measures to Increase Engaged Time-On-Task and Ensuring Compliance Therewith," must be observed and implemented. Additionally, the safety of all participants must be ensured.
- 7. The documents of the selected student-athletes must be submitted to their respective PESS Coordinators by **December 29, 2024**.
- 8. PESS Coordinators must complete the selected student-athlete registration using the provided link (https://tinyurl.com/DivisionSportsCompetitions) by January 2, 2025.
- 9. Student-athletes are required to have their coaches, assistant coaches, or chaperones present during the conduct of the events.
- 10. Enclosed to this Memorandum are the following:

- 11. All delegations must adhere to the provision on DepEd Order No. 40, s. 2012 entitled DepEd Child Protection Policy and DepEd Order No. 55, s. 2013 entitled IRR of Republic Act No. 10627 Anti Bullying Act Of 2013. As such, delegation officials shall be held responsible for the protection, welfare and safety of their pupil/student/athletes. And in compliance with the said orders the following guidelines shall be observed in the conduct of each sporting event.
 - a. Team Managers are responsible in the conduct of their delegation especially when their team/s are competing any time of the day.
 - b. Any athlete, coach, assistant coach and chaperone involved in any altercation especially physical shall be banned from the Palarong Pampaaralan (Provincial Meet) and CLRAA and the player on the team shall be suspended in the entire duration of present Palarong Pampaaralan (Provincial Meet).

- 12. Likewise, DepEd Order No. 48, s. 2016 (Policy Guidelines on Comprehensive Tobacco Control) shall be observed.
- 13. In compliance to DepEd Order No. 13, s. 2017 entitled Policy and Guidelines in Healthy Food and Beverage Choices in Schools and DepEd Offices, all Team Managers shall promote healthy eating habits by making available healthy and nutritious food and beverages. Likewise, No Alcohol, No Smoking and No Gambling policies for the duration of Division Sports Competitions shall be observed. Violators shall be dealt with accordingly.
- 14. Tournament Directors (TDs) shall manage the daily attendance of the officiating officials and submit the same to the Technical Management Committee. They will also submit an evaluation on the performance of the officiating officials. Feedback on the attendance of the officiating officials shall be reported to their respective Team Managers. If there will be officiating officials who are impartial and remiss in the performance of their duty at the same time will be detrimental in the success conduct of the competitions, TDs have the authority to relieve them on their duty and report the incident to the Technical Management Committee for appropriate action. TDs shall also ensure that there are Medical Officers on duty before starting each game.
- 15. Wearing a uniform is not a requirement for eligibility to play.
- 16. All expenses incurred for the said events shall be charged to School Maintenance and Other Operating Expenses (MOOE) or other available funds subject to the usual accounting and auditing rules and regulations.
- 17. This Memorandum shall serve as the travel authority of all participants.
- 18. Immediate and wide dissemination of this Memorandum is desired.


