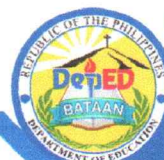

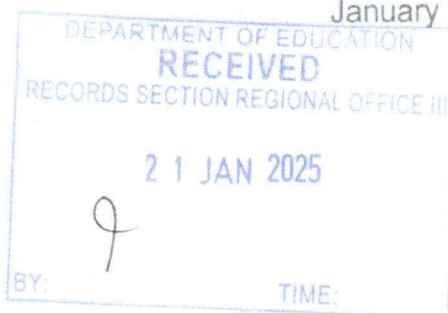


1. Updates on the union's upcoming activities
