- 1. The Department of Education (DepEd) through the Bureau of Education Assessment (BEA) in coordination with the Curriculum Implementation Division (CID) will administer the Accreditation and Equivalency (A&E) Test to Alternative Learning System (ALS) Learners for SY 2024-2025 on January 26, 2025 at various testing centers.
- 2. Pursuant to DepEd Order No. 55, s. 2016 (Policy Guidelines on the National Assessment of Student Learning for K to 12 Basic Education Program), the A&E Test aims to measure the competencies and life skills of those who have not attended or finished formal elementary or secondary education. This assessment shall allow the learners to obtain certification of completion of different exits in Basic Education, which may be used to access further education, job promotion, entry to job training, and employment.
