- This Office through the Curriculum Implementation Division (CID), shall conduct the 2025 Division Festival of Talents (DFOT) with the theme, Galing, Talino, at Husay ng mga Batang Makabansa sa Diwa ng MATATAG na Adhika on February 17-20, 2025, at various venues.
- 2. The 2025 DFOT aims to provide opportunities for learners from public and private elementary and secondary schools, as well as those from Special Program in the Arts (SPA), Sining Tanghalan, Technolympics (TLE), Festival of Values and Virtues (ESP), Musabagah (AP), READ-A-THON (English/Filipino), Division Robotics (Science). It also serves as a platform to strengthen both teachers' and learners' knowledge and skills through insights shared by a panel of experts.
- There will be simultaneous opening programs at the respective venues 3. during the event.
