- 1. This Office, through the Curriculum and Implementation Division (CID), announces the conduct of the 2025 Division Tolling of Bells Competition on March 4, 2025, at 8:00 AM onwards at the Bataan Tourism Office, Roman Superhighway, Balanga City, Bataan.
- 2. The Tolling of Bells Competition is an annual event held in commemoration of Araw ng Kagitingan (Day of Valor), a national observance honoring the bravery and sacrifices of Filipino war veterans during World War II. This initiative seeks to instill a sense of patriotism, nationalism, and historical awareness among learners while providing them with an opportunity to actively participate in the official ceremony. The competition aims to select a student representative who will take part in the official tolling of bells during the Araw ng Kagitingan commemoration.
- 3. The following individuals are expected to take part in the activity:
- a) One (1) student contestant per junior high school (Grade 7)
- b) One (1) teacher-coach per contestant
- Fifteen (15) Araling Panlipunan Department Heads
- d) Education Program Supervisor (EPS-AP)

CONTEST GUIDELINES AND MECHANICS OF 2025 DIVISION TOOLING OF BELLS IN CELEBRATION OF ARAW NG KAGITINGAN

- The competition is open to all grade seven (7) learners, both from private 1. and public schools, who are enrolled for the school year 2024-2025.
- There shall be one (1) learner-contestant per Junior high school. 2.
- 3. The competition shall use English as the primary language. The contest piece will be given by the concerned EPS-Araling Panlipunan coming from the Central Office, prior to the actual date of the contest. Each contestant should wear school uniform during the contest proper.
- Each learner-contestant shall deliver his/her contest piece in 1-5 minutes. 4.
- The decision of the Board of Judges is final. 5.

Criteria:

- A. Delivery and Performance = 30% -words are pronounced distinctly and correctly
- B. Memorize the contest piece = 40%
- C. Over-all impact= 30%
- -voice and articulation
- appropriateness of understanding are in unison to convey the message effectively and with great impact.
