1. This Office announces the commencement of localized training for selected athletes in preparation for the 2025 Palarong Pampook, starting on February 8, 2025, at schools with athletes selected to participate in the 2025 CLRAA.
2. The objectives are the following:
 - Improve physical and technical skills for better competition results;
 - Boost strength, endurance, and fitness through personalized training; and
 - Foster cooperation and support among athletes to strengthen team dynamics.
3. Schools are encouraged to implement localized training; however, the training schedule should be set after class hours and on weekends to avoid disrupting regular classes, in accordance with the provisions of DepEd Order No. 9, s. 2005, titled "Instituting Measures to Increase Engaged Time-On-Task and Ensuring Compliance Therewith."
4. Implementation of this training must adhere to the provisions of DepEd Order No. 019, s. 2008, titled "Implementation of the No Collection Policy in Public Elementary and Secondary Schools."
5. The participants' safety must be ensured, and parental consent must be secured (see attached enclosure).
