1. Pursuant to Regional Memorandum No. 223, s. 2025 dated July 4, 2025, the Department of Education joins the nation in celebrating the 2025 Nutrition Month with the theme **"Sa PPAN Sama-sama sa Nutrisyong Sapat Para sa Lahat"** and the subtheme **"Food at Nutrisyon Security, Maging Priority! Sapat na Pagkain, Karapatan Natin!"**.
2. The objectives of the 2025 Nutrition Month celebration are the following:
 - a. to raise awareness on the importance of proper nutrition in addressing malnutrition and to promote healthy diets and food security as key components of national and local development plans; and
