– RO through Human Resource Development Division (HRDD), alongside the **physical copies of the completed Validation Form (Regional Copy)**, which shall serve as reference for the assigned Facilitators during the administration of the assessment.” Deadline for the submission of the completed validation forms is **September 4, 2025**.

7. The assessment personnel from the Regional Office (RO) and SDOs who shall serve in the activities relative to the conduct of NASH FY 2025 (Batch 1) are listed in the enclosure of this memorandum.

8. The SDOs where the Assessment Sites are located are requested to provide the necessary administrative support, including the assignment of **medical staff** on-site to ensure the safety and welfare of all personnel and examinees. For the number of needed administrative support personnel, please refer to the said enclosure.

9. Examinees are reminded to ensure that their devices meet the **minimum technical requirements** for the NASH, to wit:

Operating System	Processor	Memory (RAM)	Storage
Windows 10 (Version 20H2 or later) or Windows 11 (Home or Enterprise editions); macOS 10.15 (Catalina) or newer	At least a Dual-Core processor (Intel Core i3 or AMD Ryzen 3 equivalent or higher)	Minimum of 4 GB	At least 500 MB of available free disk space

10. Examinees are also required to bring their own pocket wifi during the mock assessment and actual assessment. For uniformity and easy identification, examinees shall wear white polo shirt, while Assessment Site Personnel shall wear their respective color attire as designated by the RTWG.

11. Assessment personnel and examinees shall be provided with morning snacks and lunch during the mock assessment and actual assessment.

12. Travel and other incidental expenses of assessment personnel shall be charged to the downloaded Program Support Fund (PSF) subject to the usual accounting and auditing rules and regulations.

13. Assessment personnel shall be entitled to Compensatory Time Off (CTO) subject to existing rules and regulations on the grant of CTO.
