**POSTPONEMENT OF ALL SCHEDULED ACTIVITIES IN SDO BATAAN DUE TO
MEMORANDUM CIRCULAR NO. 97, S. 2025**

To: Assistant Schools Division Superintendent
Chief Education Supervisors
Education Program Supervisors
Public Schools District Supervisors
Public Elementary/Secondary School Heads
All Others Concerned

1. In reference to **Memorandum Circular No. 97, s. 2025** issued by the Office of the President through the authority of President Ferdinand R. Marcos Jr., signed by Executive Secretary **Lucas P. Bersamin**, suspending work in government offices and classes at all levels in Metro Manila and several provinces, including **Bataan**, on **22 September 2025**, due to the anticipated heavy rainfall brought about by **Super Typhoon "Nando"** and the **Southwest Monsoon**, the Schools Division Office of Bataan hereby announces the **postponement of all scheduled activities**.
2. Affected activities include, but are not limited to, the following:
 - 2.1 Ranking activities and related evaluations;
 - 2.2 School-Based Feeding Program (SBFP) related activities;
 - 2.3 TFG Leadership Summit;
 - 2.4 Meetings, conferences, and workshops scheduled at the Division and district levels;
 - 2.5 Other official gatherings and field-based engagements.
3. The suspension of these activities is necessary to ensure the safety and welfare of all personnel, stakeholders, and participants. Rescheduling will be announced through separate advisories once normal operations resume.
4. However, personnel whose services are required for **basic, vital, and health services, preparedness, and disaster response duties** are directed to continue rendering service as needed to ensure continuity of essential government functions, consistent with the provisions of Memorandum Circular No. 97, s. 2025.

MEMORANDUM CIRCULAR NO.97

Upon the recommendation of the National Disaster Risk Reduction and Management Council, and in view of the forecasted heavy rainfall that will be brought about by Super Typhoon "Nando" and the Southwest Monsoon, work in government offices and classes at all levels in Metro Manila, Abra, Antique, Apayao, Bataan, Batanes, Batangas, Benguet, Bulacan, Cagayan, Cavite, Ifugao, Ilocos Norte, Ilocos Sur, Isabela, Kalinga, La Union, Laguna, Mountain Province, Nueva Ecija, Nueva Vizcaya, Occidental Mindoro, Oriental Mindoro, Pampanga, Pangasinan, Palawan, Romblon, Rizal, Tarlac and Zambales are hereby suspended on 22 September 2025.

However, agencies responsible for basic, vital and health services, preparedness and response duties must continue to remain operational to ensure continuity of essential government functions. Non-vital government employees of subject agencies and all other government employees may be engaged under approved alternate work arrangements, subject to applicable laws, rules and regulations.

Further thereto, the localized cancellation or suspension of classes and/or work in government offices in other regions may be implemented by their respective Local Chief Executives, pursuant to relevant laws, rules and regulations.

The suspension of work in private companies and offices is left to the discretion of their respective heads.

This Circular shall take effect immediately.
