1. This Office, through the Curriculum Implementation Division (CID), will conduct A Capacity Building for School Testing Personnel on the Administration and Utilization of the Assessment Tools Used for Aral Program on September 15-16, 2025 (first batch) and September 22-23, 2025 (2nd batch), at 8:30 am at Villa Amanda Resort Corp., Abucay, Bataan.
2. The activity aims to:
