1. In line with the Department of Education's thrust to address learning gaps and ensure that every learner acquires foundational skills in reading, the ARAL Program (Academic Recovery and Accessible Learning Program) is being implemented as one of the flagship initiatives under the National Learning Recovery Plan (NLRP).
2. The Schools Division Office of Bataan (SDO-Bataan) recognizes the importance of formally launching this program at Tomas Pinpin Memorial Elementary School, Abucay, Bataan, on September 15, 2025, 9:00 AM to 12:00 NN, to cascade its framework, objectives, and strategies to all districts and schools.
