In addition to managing the school's financial resources, including working with the principal to create and approve the budget, it allows for greater influence over the instructional process. Since the principal is the sole person with the authority to develop

the school's strategic plans, one problem SBM faces is the lack of planning and stakeholder distinction. This approach can boost the commitment to students' well-being by enhancing the standard of instruction, school administration, and the learning environment in all schools.

The overall quality of basic education services has improved as a result of schools' ongoing efforts to improve their practices. This includes increased community and parent involvement and the creation of a safer and healthier learning environment.

It has better control over the learning mechanism. It is also in charge of managing the school's financial resources, such as creating and approving the budget in collaboration with the head. Since the school head has the power to create the school's strategic plans, one of the obstacles SBM faces is the incapacity of stakeholders to plan and differentiate. By improving the standard of instructional design and school administration, it would strengthen the dedication to students' welfare and improve the learning environment across all schools.

Curriculum planning that is successful, resource management, accountability, and governance principles all contribute to effective administration and operations of schools. Because schools are always looking to improve their methods, there is a subsequent improvement in the fundamental education services, including parent and community involvement and the provision of a safe and healthy learning environment.
