Item	Original Specification	Revised / Additional Requirement
1. AM Snacks	AM snacks only (no beverage specified)	Include one (1) bottle of 330mL mineral water (sealed, branded, and properly labeled) per participant.
2. PM Snacks	PM Snacks with coke (unspecified volume)	Must include one (1) bottle of Coca-Cola, 190mL. Equivalent soft drink of the same brand and volume may be accepted.
3. Meal Packaging	Meals and snacks no specified packaging	All meals (AM Snack, Lunch, PM Snack) shall be prepared in individual packs, properly sealed and labeled per participant for hygiene and safety.

II. ADDITIONAL REMINDERS TO ALL BIDDERS

The above amendments shall form part of the Bid Documents and shall be considered in the preparation of bids.

Any provision in the previously issued bidding documents inconsistent with this Bid Bulletin is hereby amended or modified accordingly.
