Pursuant to DepEd Unnumbered Memorandum dated October 22, 2025, titled Declaration of Midyear Break as Wellness Break (October 27-30, 2025) and Guidelines for Professional Development Activities, this Office informs all concerned regarding the Addendum to Division Memorandum No. 466, s. 2025 titled "Stakeholders' Convergence 2025: A Confluence of Partnership and Recognition in Upholding the Spirit of Bayanihan in Education," to be held on October 29, 2025.
