1. In reference to Division Memorandum No. 279, s. 2025 titled "**Monitoring of Private Schools in the Schools Division of Bataan**", this Office announces the **resumption of the conduct of the said monitoring activities** from November 4- 28, 2025.
2. This is pursuant to DepEd Order No. 88, s. 2010 titled "2010 Revised Manual of Regulations for Private Schools in Basic Education", Section 25 of the Order stating that "All private educational institutions shall be subjected to reasonable supervision and regulation by the Department".
3. This monitoring aims to ensure the compliance of private schools to educational standards and regulations relative to DepEd Order 88, s. 2010; recognize private schools' best practices; and identify issues and concerns as bases for provision of technical assistance.
