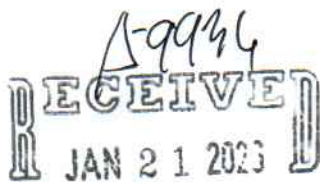

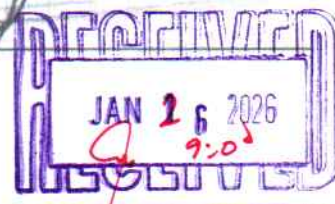

1. Anent to Department of Education Order No. 12, series of 2025, titled **"Multi-Year Implementing Guidelines on the School Calendar and Activities,"** the Bureau of Learner Support Services-Youth Formation Division (BLSS-YFD), announces the **conduct of the Supreme Elementary Learner Government (SELG) and Supreme Secondary Learner Government (SSLG) Elections for School Year 2026-2027** in all public elementary and secondary schools.

School-Based Elections	January 26-30; February 2-13, 2026
District-Division Elections	February 16-27; March 2-6, 2026
Regional Federation Elections	March 9-27, 2026
National Federation Elections	To be announced in a separate Memorandum

2. The Learner Government Program (LGP) is recognized as the primary co-curricular, learner-led organization authorized to implement relevant programs, projects, and activities in schools nationwide. The establishment and strengthening of the SELG and SSLG aim to develop leadership competencies, promote learner participation in school governance, and amplify learners' voices in decision-making.

3. All Division Youth Formation Coordinators (DYFCs) are requested to provide the necessary technical assistance and guidance to ensure the orderly, timely, and effective conduct of the elections. In addition, schools are advised to refer to the previous issued election guidelines for the proper guidance on the conduct of
