This Office informs all concerned of the request from the Public Employment Service Office (PESO), Province of Bataan, to strengthen coordination with the Department of Education in the conduct of Career Guidance activities in public secondary schools.

Schools are advised to observe the following when inviting external speakers for Career Guidance:

- **Junior High School (Grades 9–10):** Coordinate with the Municipal PESO and Provincial PESO as primary resource persons.
- **Senior High School:** Coordinate with the Municipal PESO, Provincial PESO, and the Department of Labor and Employment (DOLE) – Bataan, subject to proper concurrence.

This measure aims to ensure that learners receive accurate, relevant, and labor market-responsive career information.

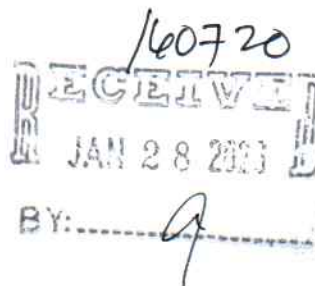

Dear Madam:

In line with the Public Employment Service Office's (PESO) mandate to provide accurate, timely, and labor market-responsive career information, we recognize the importance of strengthened coordination with the Department of Education (DepEd) in the conduct of Career Guidance activities in public secondary schools. As PESO consistently supports schools through career advocacy and employment facilitation initiatives, clearer institutional guidance from DepEd on the appropriate engagement of government resource persons will help ensure that learners receive relevant, age-appropriate, and credible career information aligned with their educational level and workforce readiness.

To ensure the consistent provision of accurate, relevant, and needs-based labor market and career information to learners, we respectfully propose that DepEd issue an advisory or directive to all public JHS and SHS to observe the following coordination protocols when requesting external speakers for Career Guidance activities:

- For **Junior High School (Grades 9–10)**, schools may be advised to formally extend invitations to the **Municipal Public Employment Service Office (PESO)** and the **Provincial PESO** as primary resource persons.
- For **Senior High School**, schools may be guided to coordinate with the **Municipal PESO**, **Provincial PESO**, and the **Department of Labor and Employment (DOLE) – Bataan**, subject to proper concurrence.

The proposed guidance aims to strengthen inter-agency alignment, minimize duplication of efforts, and ensure that the right information is delivered by the appropriate institutions to the intended learner groups. Ultimately, this will enhance the quality, consistency, and credibility of Career Guidance programs across public secondary schools.
