DATE : 18 February 2025

On October 23, 2025, Republic Act No. 12313, or *Lifelong Learning Development Framework (LLDF) Act*, was approved to promote inclusive and equitable lifelong learning. The law expands the composition of the Philippine Qualifications Framework–National Coordinating Council (PQF-NCC) to include the Department of the Interior and Local Government (DILG) and provides for the designation of Learning Cities, Municipalities, and Barangays in partnership with Local Government Units (LGUs).

Through the Department of Education’s Legislative Liaison Office, under the Office of the Undersecretary for Legal and Legislative Affairs, and the PQF-NCC Permanent Secretariat, your office is invited to participate in the **Online Public Consultation on the Draft Implementing Rules and Regulations (IRR) of R.A. No. 12313**, to be held on:

27 February 2026 (1:30–4:30 PM); Platform: MS Teams

The consultation aims to: a) review consolidated stakeholder inputs; b) resolve key issues and refine provisions; and c) build consensus toward the finalization of the IRR.
