2. The above link contains the four (4) RQA lists in PDF format, prepared and made accessible through the support of the Information Technology (IT) Unit.

3. All applicants are strongly advised to carefully review their respective scores and details as reflected in the posted initial partial results.

**3.1** The **secret code** refers to the serial number located at the **upper-left portion of the signed score sheet** issued during the paper evaluation. Please refer to the example provided below.

**3.2** Applicants may verify the accuracy of their secret code by comparing the **breakdown of scores** in the Initial Partial Result with those reflected in your signed score sheet.

- If the scores match, this confirms that the assigned secret code is correct.
- If there is any discrepancy, applicants are advised to submit a request for correction through the link provided in this Memorandum.

5. To ensure proper documentation and processing, all requests for correction shall strictly follow these guidelines:

5.2 Applicants must accurately fill out all required fields in the form.

5.3 If the concern involves a score discrepancy, the applicant is required to upload a clear and readable copy of the signed score sheet or IES as supporting evidence.

5.4 Requests without complete details or without supporting documents (if required) shall not be processed.

5.5 Applicants are advised to double-check all entries before clicking the link submission button to avoid delays.

6. Submission of requests for correction shall be accepted within the prescribed period until May 8, 2026 (Friday), 5:00PM. Requests submitted beyond the deadline shall no longer be entertained.

7. All applicants are reminded that the posted results are initial and partial, and are still subject to validation and finalization after all verified corrections have been processed.
