All documents must be authentic, duly signed, and valid at the time of submission. **The Omnibus Sworn Statement form shall be signed by a Legal Counsel.** Ensure that all data in CSC Form 212 (Revised 2025,PDS) are complete and updated. Any falsification or misrepresentation shall result in disqualification and appropriate legal action per CSC rules.

6. The Human Resource Merit Promotion and Selection Board (HRMPSB) shall:

- 6.1 Ensure a fair, transparent, and objective evaluation based on applicable CSC and DepEd guidelines;
- 6.2 Uphold the principles of merit, fitness, and equal opportunity, with due consideration to all applicants regardless of SOGIE, civil status, religion, political affiliation, disability, or ethnicity;
- 6.3 Conduct paper evaluation, behavioral event interviews, and examinations;
- 6.4 Require original documents for verification during ranking;
- 6.5 Maintain strict compliance with Data Privacy laws.
