10**

DATE : May 13, 2026

1. Pursuant to Section 58 of the Implementing Rules and Regulations of Republic Act No. 12009, otherwise known as the New Government Procurement Act, the Bids and Awards Committee (BAC) shall conduct the opening of bids immediately after the prescribed deadline for the submission and receipt of bids. The opening of bids shall be undertaken in accordance with the procedures and requirements set forth under existing procurement laws, rules, and regulations to ensure transparency, competitiveness, accountability, and equal opportunity among prospective bidders.
2. Accordingly, all bids received within the prescribed period shall be duly recorded and opened by the BAC in the presence of the participating bidders or their duly authorized representatives who choose to attend the proceedings. The BAC shall likewise ascertain the completeness of the documentary requirements and conduct the preliminary examination of bids based on the criteria prescribed in the bidding documents and applicable procurement guidelines.
3. The conduct of the opening of bids immediately after the deadline for submission is intended to uphold the integrity of the procurement process and ensure that no bid shall be accepted, modified, or withdrawn after the prescribed deadline, except as may be allowed under existing rules and regulations.
4. In this regard, this Office announces the conduct of Opening of Bids for the Procurement of Meals for the Division School-Based Training of Teachers on the Revised K to 12 Curriculum for Grades 6, 9, and 10 on May 25–28 & June 2-5, 2026.
